SUBJECT:	2023 Summary of New Laws

## Purpose

This 2023 Summary of New Laws is designed to serve as a notice of the 82nd Legislative Assembly's 2023 Regular Session enactments which affect agency responsibilities. This summary is a reference tool, designed to serve as a guide to new programs and law changes that have demonstrable impacts on Business Oregon. It is important to note statutory modifications are merely described and have not been fully vetted. Employees are directed to consult with their managers regarding interpretation and compliance with new laws, in some cases it may be necessary to consult the Department of Justice on the meaning of specific language. Managers are already working to pull together necessary parties and resources for implementation.

# Background

The State Legislature convened from January 17, 2023, to June 25, 2023. Almost 3,000 bills were introduced; over 650 passed both chambers, were signed into law by the Governor, and will become effective over the next several months. Approximately 270 bills were identified by Business Oregon as potentially impacting agency responsibilities and were tracked throughout session. This summary highlights 48 measures directly or indirectly applicable to agency responsibilities. Attached to this memorandum is a summary of the agency budget and an index by bill number.

Each of the highlighted measures includes a link to overview page the <u>Oregon Legislative</u> <u>Information System (OLIS)</u>. For final bill language you will need to look to the "Enrolled" version of the bill, a link is included for your convenience. The "Analysis" tab has information helpful to understanding the bill intent, including the Staff Measure Summary, Revenue Impact Statement, and Fiscal Impact Statement or Budget Report. Additional information helpful to understanding legislative history is available under the "Testimony" tab.

Each enrolled bill <u>approved by the Governor</u> is assigned an Oregon Laws chapter number by the Secretary of State. Chapter numbering begins with 1 for each regular or special session. Once compiled, you will be able to find the 2023 Regular Session Oregon Laws on the Oregon Legislature's website <u>here</u>. In early 2024 these new laws will be codified into the Oregon Revised Statutes and will become available <u>here</u>.

# New Laws by Subject Matter

#### Arts and Cultural Trust:

- <u>HB 2071</u> (Oregon Laws 2023, chapter 490) Extends sunset provisions for various tax credits, in part to realign the tax credit review schedule. Section 8 extends Cultural Trust tax credit sunset to 2027 tax year. Effective 91 days following adjournment sine die. Enrolled version of the bill is <u>here</u>.
- <u>HB 3532</u> (Oregon Laws 2023, chapter 552) Allows Arts Program to use up to five percent of value of Trust for Cultural Development Account for certain administrative purposes. This was an **agency concept to increase resources for Cultural Trust program funding**. Related agency POP 114 was not included in the budget and the agency will still need budgetary authority to use the new flexibility granted in the bill. Effective January 1, 2024. Enrolled version of the bill is <u>here</u>.
- HB 5030 See *Budget* section for grant for new Center for Native Arts and Cultures.
- SB 5506 See *Budget* section for grants to cultural venues and Literary Arts, Inc. headquarters.

#### Broadband

- <u>HB 2049</u> (Oregon Laws 2023, chapter 489) Establishes Oregon Cybersecurity Center of Excellence within Portland State University to supplement activities of State Chief Information Officer regarding cybersecurity. Oregon Broadband Office was not named in bill, but all state agencies are directed to assist council and some involvement seems likely. Effective upon passage. Enrolled version of the bill is <u>here</u>.
- <u>HB 3201</u> (Oregon Laws 2023, chapter 338) Priority bill for Oregon Broadband Office, aligns state law with federal requirements to allow receipt of federal broadband funds. Effective upon passage. Enrolled version of the bill is <u>here</u>.

#### Budget

- <u>HB 5005</u> (Oregon Laws 2023, chapter 596) **Bond authorization bill** for 2023-25 biennium. Includes \$150M for Seismic Rehabilitation, \$600M revenue bond volume cap, and total Lottery Bond limitation of \$501M (see HB 5030 for a list of Lottery Bond projects). Effective July 1, 2023. Budget report is <u>here</u>. Enrolled version of the bill is <u>here</u>.
- <u>HB 5006</u> (Oregon Laws 2023, chapter 597) Capital Construction bill for 2023-25 biennium. Business Oregon is not named. Effective July 1, 2023. Enrolled version of the bill is <u>here</u>.
- <u>HB 5029</u> (Oregon Laws 2023, chapter 598) Other Fund bill, includes total Lottery Fund resources for Business Oregon but not specific uses. Includes distribution to Regional Solutions in Section 5 and distribution to counties for economic development in Section 8. Effective July 1, 2023. Budget report is <u>here</u>. Enrolled version of the bill is <u>here</u>.
- <u>HB 5030</u> (Oregon Laws 2023, chapter 599) **Lottery Bond bill** for the 2023-25 biennium. Includes \$30M for Special Public Works Fund in Section 1; \$10M for Levee Project Grant

Fund in Section 4; \$50M for Child Care Infrastructure Fund in Section 6; \$27.8M to support five identified projects for wastewater or industrial site improvement in Sections 21, 22, 23, 35, and 36; \$3M for a new Center for Native Arts and Cultures in Section 38; and \$20M in 2023-25 plus \$20M in 2025-27 for Coos Bay port dredging in Sections 44 and 45. See also SB 634 for levee legislative history. Effective July 1, 2023. Staff Measure Summary is <u>here</u> and Fiscal Impact Statement is <u>here</u>. Enrolled version of the bill is <u>here</u>.

- <u>HB 5045</u> (Oregon Laws 2023, chapter 21) Budget Rebalance bill for 2021-23 biennium. Effective date April 6, 2023. Budget report is <u>here</u>. Enrolled version of the bill is <u>here</u>.
- <u>HB 5046</u> (Oregon Laws 2023, chapter 88) Continuing resolution, provides continuing expenditure authority for state agencies without adopted budgets for 2023-25 biennium. Effective date July 1, 2023. Enrolled version of the bill is <u>here</u>.
- <u>SB 5502</u> (Oregon Laws 2023, chapter 375) Department of Administrative Services' (DAS) agency budget bill, includes payment to county fairs in Section 4. Effective July 1, 2023. Enrolled version of the bill is <u>here</u>.
- <u>SB 5506</u> (Oregon Laws 2023, chapter 605) Christmas tree/end of session bill. There are numerous items that affect Business Oregon, including but not limited to \$5.6M General Fund for grants to 78 distinct cultural venues in Section 254; \$1M General Fund to Literary Arts, Inc. for a new headquarters renovation in Section 255, \$15M Lottery Fund for nine distinct rural infrastructure projects in Section 256, and a Special Purpose Appropriation for an additional \$50M General Fund for Oregon CHIPS program in Section 292. Effective upon passage. Budget report is here. Enrolled version of the bill is here. The Governor signed SB 5506 but with a line-item veto of four items unrelated to Business Oregon, her letter to the Secretary of State is here.
- <u>SB 5524</u> (Oregon Laws 2023, chapter 475) Business Oregon's agency budget bill, see attachment for agency budget summary. Effective July 1, 2023. Budget report is <u>here</u>. Enrolled version of the bill is <u>here</u>.
- <u>SB 5543</u> (Oregon Laws 2023, chapter 22) Bond authorization change bill for 2021-23. Effective date, April 6, 2023. Enrolled version of the bill is <u>here</u>.
- <u>SB 5544</u> (Oregon Laws 2023, chapter 23) Capital Construction adjustment bill for 2021-23. Effective date, April 6, 2023. Enrolled version of the bill is <u>here</u>.
- <u>SB 5545</u> (Oregon Laws 2023, chapter 24) Other Fund rebalance bill for 2021-23. Effective date, April 6, 2023. Enrolled version of the bill is <u>here</u>.

## Central Operations/Statewide Administration

- <u>HB 2112</u> (Oregon Laws 2023, chapter 35) Updates definitions and terminology used in public records law pertaining to records retention. Removes references to obsolete technology. Effective January 1, 2024. Enrolled version of the bill is <u>here</u>.
- <u>HB 2490</u> (Oregon Laws 2023, chapter 307) Exempts records concerning cybersecurity from disclosure. Effective January 1, 2024. Enrolled version of the bill is <u>here</u>.

- HB 2649 See *COBID* section for new requirements for equity and apprentices on public improvement contracts.
- <u>HB 2805</u> (Oregon Laws 2023, chapter 417) Modifies scope of public meetings law, creates new training requirement for local governing bodies, and expands Oregon Government Ethics Commission oversight of public meetings law. Effective 91 days following adjournment sine die. Enrolled version of the bill is <u>here</u>.
- <u>HB 2806</u> (Oregon Laws 2023, chapter 252) Modifies public meetings law to allow **executive** sessions to discuss safety, facility security, and responses to cybersecurity threats. Effective upon passage. Enrolled version of the bill is <u>here</u>.
- <u>HB 3127</u> (Oregon Laws 2023, chapter 256) TikTok bill, **prohibits download of certain products** onto state information technology assets. Effective 91 days following adjournment sine die. Enrolled version of the bill is <u>here</u>.
- HB 3332 See *COBID* section for new Build America Buy America requirements.
- <u>HB 3550</u> (Oregon Laws 2023, chapter 553) Requires state agency to purchase or lease zeroemission vehicles unless certain exceptions apply. Effective January 1, 2024 and applies to purchases and leases of light-duty vehicles beginning on January 1, 2025. Enrolled version of the bill is <u>here</u>.
- <u>HB 3572</u> (Oregon Laws 2023, chapter 559) Modifies **public procurement law** to allow contracting agency to grant **preference to benefit company** under certain conditions. Effective 91 days following adjournment sine die and becomes operative on January 1, 2024. Enrolled version of the bill is <u>here</u>.
- <u>SB 11</u> (Oregon Laws 2023, chapter 565) Requires state boards or commissions conducting public meetings through electronic means to record and publish recordings on a website available to the public. Applies to state boards and commissions whose members are subject to Senate confirmation. Exempts executive sessions. Effective January 1, 2024. Enrolled version of the bill is <u>here</u>.
- <u>SB 692</u> (Oregon Laws 2023, chapter 160) **Requires state agencies to use DAS information system to track internal investigations** related to allegations of workplace discrimination and harassment. Effective January 1, 2024. Enrolled version of the bill is <u>here</u>.
- <u>SB 907</u> (Oregon Laws 2023, chapter 196) Makes it an unlawful employment practice under specified conditions to deny employment or discriminate against employee or candidate because they refuse hazardous condition of employment. Effective January 1, 2024. Enrolled version of the bill is <u>here</u>.
- <u>SB 1047</u> (Oregon Laws 2023, chapter 127) Equity in public procurement omnibus bill. Raises contract price threshold under which less onerous procurement methods apply. For state public contracts with price of at least \$10,000 requires documentation of actions taken to provide notice of procurement to Governor's Policy Advisor for Economic and Business Equity and consideration for participation by businesses certified by the Certification Office for Business Inclusion and Diversity (COBID). Requires DAS promote policy of diversity, equity and inclusion in public contracting by increasing public contracting opportunities for COBID businesses. Requires DAS review results of disparity study, implement priority

recommendations of study, and to report periodically to Governor's advisor concerning progress. Effective 91 days following adjournment sine die and becomes operative January 1, 2024. Enrolled version of the bill is <u>here</u>.

 <u>SB 1095</u> (Oregon Laws 2023, chapter 604) – Makes changes to boards and commissions to account for new Oregon congressional district, includes changes to Oregon Growth Board membership. Effective upon passage. Enrolled version of the bill is <u>here</u>. The Governor signed SB 1095 but with a line-item veto of the emergency clause, her letter to the Secretary of State is <u>here</u>.

#### COBID

- <u>HB 2295</u> (Oregon Laws 2023, chapter 497) **Expands certification through COBID** from businesses owned by service-disabled veterans to include businesses owned by any veteran. The <u>Fiscal Impact Statement</u> notes that "OBDD may need to return to the Legislative Emergency Board or a subsequent legislative session if budgeted resources prove insufficient to cover the actual costs of this measure." Effective 91 days following adjournment sine die and becomes operative on January 1, 2024. Enrolled version of the bill is <u>here</u>.
- <u>HB 2649</u> (Oregon Laws 2023, chapter 504) New requirement on public improvement contracts for outreach to women, minority individuals and veterans under described conditions. Includes aspirational target of having individuals in one or more of these groups perform at least 15% of the total work hours performed under the contract. Requires reporting on efforts as condition of contract. The bill also includes a significant apprenticeship component, it requires reporting on the use of apprentices, provides penalties for failure to meet requirements for use of apprentices, and increases the percentage of work that must be completed by apprentices. Effective 91 days following adjournment sine die. Most provisions of the bill become operative for contracts beginning in 2024, but the higher utilization of apprentices will begin in 2027. Enrolled version of the bill is <u>here</u>.
- <u>HB 3332</u> (Oregon Laws 2023, chapter 541) New Build America Buy America requirements for certain DAS and Oregon Department of Transportation (ODOT) funded projects. Provides for waiver under specified circumstances. Requires DAS stand up a technical assistance and grant program to help COBID certified firms comply. Effective 91 days following adjournment sine die, becomes operative for contracts beginning January 1, 2024. Enrolled version of the bill is <u>here</u>.
- SB 1047 See *Central Operations/Statewide Administration* section for new requirements around equity in procurement.
- <u>SB 1048</u> (Oregon Laws 2023, chapter 469) Establishes new program at ODOT to assist COBID firms in competing for department's public improvement contracts. Effective 91 days following adjournment sine die. Enrolled version of the bill is <u>here</u>.

#### Economic Development (Business Assistance)

- <u>HB 2058</u> (Oregon Laws 2023, chapter 12) Creates a **new award program** administered by Business Oregon for up to \$40,000 per eligible employer to mitigate costs associated with **agricultural overtime** requirements under HB 4002 from 2022. Effective March 27, 2023, the first round of awards has been completed. Governor's signing letter is <u>here</u>. Enrolled version of the bill is <u>here</u>.
- <u>HB 3409</u> (Oregon Laws 2023, chapter 442) Climate omnibus bill. Adds Business Oregon Director as member of Climate Action Commission in Section 41 and opens door to possible interagency agreement with Department of Land and Conservation and Development (DLCD) on Community Green Infrastructure Grant Program in Section 24. Effective upon passage. Enrolled version of the bill is <u>here</u>.
- <u>HB 3410</u> (Oregon Laws 2023, chapter 546) **Rural economic development package**. Business Oregon responsibilities include new \$500K matching grant program for organizations and accelerators to support the outdoor gear and apparel industry, new \$3M grant program for county fair operators to make up for lost revenue during the pandemic, and \$3M in additional funding for Small Business Development Centers (SBDCs) to support their work. The bill appropriates Lottery Funds for the above purposes. For legislative history see also HB 2910 on outdoor gear, HB 2911 on county fairs, and HB 2908 on SBDCs. See Sections 241 and 242 of SB 5506 for clarification that SBDC funding is in addition to normal funding. Effective upon passage. Enrolled version of the bill is <u>here</u>.
- <u>SB 4</u> (Oregon Laws 2023, chapter 25) <u>Semiconductor incentives package</u>. Creates Oregon Creating Helpful Incentives to Produce Semiconductors fund (Oregon CHIPS) and directs Business Oregon working with Governor's office to award \$190 million in grants and loans to businesses applying for federal semiconductor financial assistance (See also additional \$50M Special Purpose Appropriation in HB 5506). Appropriates \$10 million to Business Oregon for deposit in the University Innovation Research Fund. Establishes new Industrial Lands Loans Fund and directs Business Oregon to provide \$10 million in forgivable loans for planning projects, repayable loans for other specified development costs, and other forms of financial assistance to facilitate development of land for semiconductor related uses. Effective April 13, 2023. Enrolled version of the bill is <u>here</u>.

## Film and Video

• <u>HB 2093</u> (Oregon Laws 2023, chapter 31) – Aligns sunsets for film production development contributions and associated tax credit. Effective 91 days following adjournment sine die. Enrolled version of the bill is <u>here</u>.

#### Infrastructure

 <u>HB 2001</u> (Oregon Laws 2023, chapter 13) – Housing omnibus bill. Requires **DLCD to consult** with Business Oregon on rules for urbanization. Effective March 29, 2023. The Governor issued a signing letter that is available <u>here</u>. Enrolled version of the bill is <u>here</u>.

- <u>HB 2010</u> (Oregon Laws 2023, chapter 606) Water omnibus bill, makes several investments and policy changes related to water. Appropriates \$3M of General Fund to Business Oregon and directs agency to establish and administer two new programs related to recharging aquifers: the Aquifer Recharge Due Diligence Grant Program and the Aquifer Recharge Testing Forgivable Loan Program. See also Section 71 of SB 5506 that appropriates \$1.2M to DAS for a similar purpose. Effective upon passage. The Governor issued a signing letter that is available <u>here</u>. Enrolled version of the bill is <u>here</u>.
- <u>HB 2158</u> (Oregon Laws 2023, chapter 237) Bond technical fix and Oregon State Treasurer housekeeping bill. Provides that unused portion of amount of pass-through revenue bonds (including Industrial Development and Beginning and Expanding Farmer Revenue Bonds) authorized for issuance in preceding biennium carries forward until legislation authorizing amount of pass-through revenue bonds for current biennium is enacted. SB 225 also passed and has same language. Effective January 1, 2024. Enrolled version of the bill is <u>here</u>.
- <u>HB 2270</u> (Oregon Laws 2023, chapter 41) Agency concept to modernize and make technical adjustments to Oregon Port Revolving Fund program. Effective January 1, 2024. Enrolled version of the bill is <u>here</u>.
- <u>HB 2727</u> (Oregon Laws 2023, chapter 510) Directs DLCD to convene **work group to examine strategies for expanding early learning and care facilities** in this state. Business Oregon is not named, but this group may inform our new childcare infrastructure program in HB 3005. Effective 91 days following adjournment sine die. Enrolled version of the bill is <u>here</u>.
- <u>HB 2763</u> (Vetoed) Establishes State Public Bank Task Force. Business Oregon is responsible for staffing taskforce and hiring consultant with subject matter expertise, bill provides \$431,562 of General Fund to agency for implementation. Effective upon passage. Enrolled version of the bill is <u>here</u>. The Governor vetoed HB 2763, her letter to the Secretary of State is <u>here</u>.
- <u>HB 3005</u> (Oregon Laws 2023, chapter 523) Directs Business Oregon to provide financial assistance to eligible applicants to pay for allowable costs related to **early childcare** infrastructure activities through a new \$50M grant and loan program. See also Section 6 of HB 5030 for \$50M in Lottery Bond proceeds and Section 260 of SB 5506 for \$534,259 in Lottery Fund for program administration. Effective upon passage. Enrolled version of the bill is <u>here</u>.
- HB 3332 See *COBID* section above for new Build America Buy America requirements.
- HB 5005 See *Budget* section for \$150M for Seismic Rehabilitation and \$600M revenue bond volume cap.
- HB 5030 See *Budget* section for \$30M for Special Public Works Fund, \$10M for Levee Project Grant Fund, \$27.8M to support five identified projects for wastewater or industrial site improvements, \$3M for a new Center for Native Arts and Cultures, and \$40M for Coos Bay port dredging.
- <u>SB 225</u> (Oregon Laws 2023, chapter 174) Bond technical fix bill. Provides that unused portion of amount of pass-through revenue bonds (including Industrial Development and Beginning and Expanding Farmer Revenue Bonds) authorized for issuance in preceding biennium carries forward until legislation authorizing amount of pass-through revenue

bonds for current biennium is enacted. HB 2158 also passed and has same language. Effective upon passage. Enrolled version of the bill is <u>here</u>.

- <u>SB 1049</u> (Oregon Laws 2023, chapter 602) Program change bill. Includes sunset extension for Tide Gate Grant and Loan Fund program in Sections 36 to 38. Effective upon passage. Enrolled version of the bill is <u>here</u>.
- SB 5506 See *Budget* section for \$15M Lottery Fund for nine rural infrastructure projects and \$1M General Fund to Literary Arts, Inc. for a new headquarters renovation.

#### Tax Incentives

- <u>HB 2009</u> (Oregon Laws 2023, chapter 298) **Business incentives omnibus bill**. Creates a new Research and Development (R&D) Tax Credit and directs Business Oregon to do an annual **tax credit certification**, a one-time registration process, continued monitoring of recipients for suspension or revocation of the credit, and administration of an overall cap on the value of the credit statewide. Makes numerous **changes to the enterprise zone (EZ) program** including changes to eligibility, new program requirements, additional annual reporting, and a new school fee. Requires Business Oregon produce a **one-time study on EZ program transparency**. Makes numerous **changes to the Strategic Investment Program** (SIP) including changes to eligibility, new program requirements, requirements for the agency to provide training materials, and changes to calculations of the taxable value of projects. For legislative history see also SB 5 for R&D credit, HB 2199 for EZ changes, HB 3457 for SIP changes, and SB 1084 for competing omnibus bill. Effective 91 days following adjournment sine die but various provisions have their own operative dates and existing projects will generally be grandfathered in under rules in place at time of approval. Enrolled version of the bill is <u>here</u>.
- <u>HB 2080</u> (Oregon Laws 2023, chapter 398) Property tax expenditure sunset omnibus. Includes sunset extensions for food processors exemption, centrally assessed intangible property, and a rarely used rural industrial improvements exemption. Expands food processors exemption to include equipment for processing meat and game. Expands community solar exemption to projects serving commercial users. Bill also extends sunsets for multiple housing exemptions. Effective 91 days following adjournment sine die. Enrolled version of the bill is <u>here</u>.



# 2023-25 Legislatively Adopted Budget Summary

The 2023-25 Legislatively Adopted Budget outlines specific investments, particularly regarding business expansion, infrastructure projects, support for underrepresented populations, advanced manufacturing, childcare facilities, and cultural venues. Much of Business Oregon's budget resides in SB 5524, as well as HB 5029 (Lottery Funds), HB 5005 (General Obligation Bonds and Revenue Bonds), HB 5030 (Lottery Bonds), and SB 5506 (End of Session Bill).

The 2023-25 Legislatively Adopted Budget for Business Oregon is nearly **\$2 billion total funds**. The 22% decrease from the 2021-23 Legislatively Approved Budget is primarily due to the spend down on previously approved infrastructure projects and phaseout of one-time funding. The Legislatively Adopted Budget includes new program investments and additional funding for existing programs. The budget includes issuance of General Obligation and Lottery Bonds to make business and infrastructure investments to expand childcare infrastructure options and recapitalize infrastructure programs, such as the Special Public Works Fund (\$30M), Levee Grant Program (\$10M), and Seismic Rehabilitation (\$150M).

The 82<sup>nd</sup> Legislative Assembly also approved \$190M for advanced manufacturing business expansion and recruitment, including semiconductor firms taking advantage of the federal CHIPs Act. These funds were approved as part of the 2012-23 budget, but most of the resource will carry into the new biennium. In addition, the Emergency Board holds a Special Purpose Appropriation of \$50M for the Oregon CHIPS Fund.


